SBCT Updates

Site Updates

By the end of this month, all new sites are expected to enroll families! The Community Coordinators from Thurston and Kitsap counties are wrapping their 8-week training by ZERO TO THREE, which focuses on the foundations for launching a baby court. During this time, the teams have formalized court processes and procedures and developed the necessary internal structures to support an Early Childhood Court Program. Thurston's program started taking families on September 1, and Kitsap plans to take families in mid-late September. Spokane continues to add to their caseload and further structure their baby court program.

The Best for Babies Team continues to streamline community collaboration. A community team meeting was recently held and highlighted the Plan of Safe Care (POSC) pilot program. POSC is a pilot currently in Pierce and Yakima Counties since June 2021, with the goal of supporting substance exposed infants and teens in care with new infants with wraparound services and supportive connections. Presenters from DCYF, Help Me Grow, and Tacoma Pierce County Health Department shared communication materials that were created for service professionals and hospital staff to use when engaging families.

Sites continue to engage in local community outreach. Community Coordinators continue to inform agencies and partners about their baby court program and

explore areas of collaboration. Some activities include: providing educational presentations of the program to local agencies, building the local Active Community Teams, and connecting agencies together to discuss how to streamline work in child-parent psychotherapy (CPP) in Spokane.

The State Team continues to plan and develop state structures, including the State Advisory Board and Data Advisory Group. Formal outreach for the State Advisory Board has begun, and it is expected to convene the group in the fall. The State Team is in the process of identifying the role and potential membership of the Data Advisory Group, and hopes to formally reach out to individuals in the coming months.

Legislative Updates

Preparing for the next legislative session. We are initiating conversations and are in inquiry with our partners in preparation for the 2021-22 legislative session. Willis & Friends: Vital Signs of Early Relational Health: Autonomic Emotional Connection

When: September 22, 11:00 am - 12:00 pm PDT

About: This session will discuss Autonomic emotional connection. Autonomic emotional connection is a recently discovered observable state of co-regulation between loved ones when their stress physiology in body and brain are mutually calmed by the sight, sound, smell, touch and even taste of one another. This is especially important in infancy and early childhood as one of the true "vital signs" of early relational health, with important implications for future social emotional development and wellbeing.
