# 2018 Dependency Case Filings Rates for Children Aged Birth to Three in Washington State

This document will review infant and toddlers' involvement in Washington's child welfare system, through the measurement of dependency case filing rates in 2018. Dependency case filing rates will be used as a measure of child welfare involvement as Washington courts and the Department of Children, Youth, and Families (DCYF) collect yearly data on dependency case filings for children 0-2, disaggregated by race. This data will then be compared to total 0-2 child population estimates, provided by the Washington State Office of Financial Management. All data provided will be pulled from the year 2018.

#### High-Level Overview of Dependency Case Filings in Washington State

- In 2018, 42% of dependency cases filed in Washington were for children aged 0-2
- Children of color make up approximately 49.4% of the total 0-2 population, and White (Non-Hispanic) children 0-2 make up approximately 50.6% of the 0-2 population
- Children of color made up 48.7% of the total 0-2 dependency case filings, while White (Non-Hispanic) made up 51% of the total 0-2 dependency case filings

#### **Racial Disproportionality in Dependency Case Filings**

American Indian/Alaska Native (AI/AN) and Black children aged 0-2 were overrepresented in the child welfare system in 2018.

- AI/AN children made up approximately 2.4% of the total 0-2 population in WA, and 4.3% of dependency case filings
- Black children made up approximately 4.9% of the total 0-2 population in WA, and 6.4% of dependency case filings
- Hispanic (White) children made up approximately 20.2% of the total 0-2 population in WA, and 12.9% of dependency case filings
- White (Non-Hispanic) children made up approximately 50.6% of the total 0-2 population in WA, and
   51.0% of dependency case filings
- Multiracial\* children aged 0-2 made up an additional 23.6% of dependency case filings (It is not possible
  to accurately compare the overall state data to the dependency case filings, as the organizations
  categorize "Multiracial" differently. Each Multiracial group is defined in Figure 2 below.)
- Asian/Pacific Islander (PI)\* children aged 0-2 made up 1.5% of dependency case filings (It is not possible
  to accurately compare the overall state data to the dependency case filings, as the organizations
  categorize "Asian/PI" differently.)



### **Multiracial Children**

Dependency Case filings define "Multiracial" children in the following breakout:

Dependency Case Filings on Multiracial Children Aged 0-2	
Race	Dependency Case Filings (%)
AI/AN - Multi	11.4%
Black - Multi	9.8%
Other – Multi	2.4%


